PGHSuccess:



1.0 Introduction

This policy statement sets out our school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

- **1.1** All pupils in years 7-11 are entitled:
- to find out about technical education qualifications and apprenticeships opportunities, as part of
 a careers programme which provides information on the full range of education and training
 options available at each transition point;
- to hear from a range of local providers including
 - Hutton Grammar School
 - o Runshaw College
 - Newman College
 - Myerscough College
 - Preston's College
 - o Training 2000
 - Ask Apprenticeships

about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;

- to understand how to make applications for the full range of academic and technical courses.
 - **1.2** All pupils in years 7 to 11 are given access to online guidance and personalised information and guidance via the *National Careers Service*.
 - **1.3** All pupils in years 10 and 11 will have at least one face-to-face careers interview with an advisor, from Career North.

4.0 Premises and facilities

The school will make the main hall, training suite, classrooms, or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The school will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Lead or a member of their team.

Providers are welcome to leave a copy of their prospectus or other relevant course literature for our Careers Library, which is managed by our CIAG Advisor. This facility is available to all students at lunch and break times.

5. 0 Monitoring, Evaluation and Review

The Headteacher will ensure that:

the work of the Careers Advisor and CEIAG events are supported and monitored

a member of the Senior Leadership Team has an overview of CEIAG work and reports regularly back to the team

The effectiveness of this policy will be measured in a variety of ways:

Feedback from stakeholders through mechanisms such as the Kirkland Rowell student and parent survey;

Feedback from external visitors to the school such as the School Improvement Partner (SIP) or Ofsted;

The number of students who are NEET in October having left the school in the previous summer. This figure can be compared to national figures as well as against the equivalent figure from similar schools both nationally and within the county.

Appendix 1 – DfE Legislation effective from 01/01/23 – strengthened Baker Clause

- New legislation will come into force on 1 January 2023 that will require schools to put on at least six encounters for pupils, over the course of school years 8 to 13, with a provider of technical education or apprenticeships. These provider encounters must take place during normal school hours and meet specific criteria.
- To promote the quality and consistency of provider encounters, the legislation includes a new set of minimum information that the school must ask the provider to give to pupils during each encounter.

All maintained schools and academies must provide six encounters with a provider of technical education or apprenticeships for year 8 to 13 pupils. We have timed these six meetings to inform consideration of post-14, post-16 and post-18 options and progression to the next stage of education or training.

As a minimum, schools must offer:

- Two encounters for pupils during the 'first key phase' (year 8 or 9) that are mandatory for all pupils to attend, to take place any time during year 8 or between 1 September and 28 February during year 9.
- Two encounters for pupils during the 'second key phase' (year 10 or 11) that are mandatory for all pupils to attend, to take place any time during year 10 or between 1 September and 28 February during year 11.

All six encounters must happen for a reasonable period of time during the standard school day. Provider encounters that take place outside of school hours, for example parents' evenings, do not count towards fulfilment of the legal requirement for six provider encounters, but schools are still encouraged to provide these complementary experiences for pupils and their parents.

Schools and providers should work together and schools must ask each provider to provide information to pupils that, as a minimum, includes:

- information about the provider and the approved technical education qualifications or apprenticeships that the provider offers,
- information about the careers to which those technical education qualifications or apprenticeships might lead,
- a description of what learning or training with the provider is like,
- responses to questions from the pupils about the provider or approved technical education qualifications and apprenticeships.

Schools are already required by law to prepare a policy statement setting out the circumstances in which education and training providers will be given access to pupils. The new legislation requires schools to set out the times at which access is to be given and explain how they will meet the new legal requirement to put on six provider encounters.

Recognising that providers often have multiple qualifications and courses to offer to young people at different ages, the legislation includes flexibility for schools to arrange meetings with the same provider across more than one 'key phase'. For example, a school may invite an FE college to talk to pupils in the first key phase (year 8 to 9) about key stage 4 options and to talk to pupils in the second key phase (year 10 to 11) about post-16 options. However, within the same key phase, schools must always provide encounters with two different providers to meet the legal requirement. This means that an FE college talking to pupils multiple times across year 10 and 11 (the second key phase) would only count as one mandatory provider encounter under the terms of the legal duty.
